Sub: Disclosure under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Appointment of new Statutory Auditors.

This intimation is under Section 139 of the Companies Act, 2013 and the Rules made thereunder, which makes it mandatory for rotation of the Statutory Auditors.

Accordingly, based on the recommendation of the Audit Committee of the Company, the Board of Directors at their meeting held on 24<sup>th</sup> May, 2018 has resolved to appoint M/s.
