

Notes:

- 1 The above unaudited Financial Results for the quarter and half-year ended September 30, 2020 were reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on November 9, 2020. The Statutory Auditors of the Company have carried out Limited Review of above Financial Results.
- 2 The Financial Results of the Company have been prepared in acccordance with Indian Accounting Standards (Ind AS) notified under section 133 of the Companies Act, 2013 read with the relevant rules of the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time.
- 3 During the quarter, the Company was engaged in the business of manufacturing of Chemicals, which is the only reportable operating segment as per Ind AS 108.
- 4 The outbreak of COVID 19 pandemic and consequent lockdown imposed by the Government authorities on the travel, goods movement and transportation considering public health and safety measures has impacted the regular business operations. The results for the period are therefore not comparable with those for the previous periods. The Company has assessed the impact of pandemic on its financial results/ position based on the internal and external information available up to the date of approval of these financial results and expects to recover the carrying value of its assets. The Company continues to monitor the economic effects of the pandemic while taking steps to improve its execution efficiencies and the financial outcome. The eventual outcome of impact of the global health pandemic may be different from that estimated as on the date of approval of these financial results.
